Gilchrist Care Choices offers patients the option to seek treatments while receiving hospice support service.

When John Suprock was diagnosed with leukemia last December, the 70-year-old Air Force veteran had lost 30 pounds and could barely walk. His latest diagnosis added to an already lengthy list of health conditions including chronic obstructive pulmonary disease (COPD) and diabetes. Despite a hospital stay, his health declined and doctors offered little hope. Feeling out of options, John resolved to spend his remaining time out of the hospital and at home with his wife of 42 years, Joan.

The comforts of home boosted his spirits, and to everyone's surprise he began eating more, gaining strength and feeling more like himself. Although eligible for hospice services, John did not feel emotionally ready and didn't want to give up the option to seek treatment, especially now that he was feeling better.

As John and Joan began weighing their options, they learned about Gilchrist Care Choices—a new model of care initiated by the Centers for Medicare & Medicaid Services meant to empower people with greater flexibility in deciding between hospice care and curative treatment when faced with life-limiting illness. Unlike traditional hospice programs in which Medicare does not pay for curative treatments, Gilchrist Care Choices allows patients to continue treatment with their own doctors while receiving the support and safety net of hospice services. Gilchrist is the only hospice in Central Maryland offering this option.

"When someone is given a diagnosis and hears the word 'hospice,' it's hard to accept," explains Patti Crowl, John's Gilchrist nurse. "Gilchrist Care Choices is a wonderful option for John, because he is able to live his life to the fullest and he has the resources available when he needs them. They know they can call me any time if they have concerns, and he can still go to his hematologist."

Patti visits every two weeks, providing medical guidance, practical advice and someone to talk to. Through Gilchrist Care Choices, a social worker provides emotional and social support, while a chaplain is available to provide spiritual comfort. Families can call a triage nurse any time of day or night, helping them avoid unnecessary ER visits. And volunteers offer companionship and a helping hand.

In the meantime, John can continue to receive treatments such as blood transfusions that improve his quality of life. For John and his family, Gilchrist Care Choices has been 'a godsend'—"Gilchrist is there with us every step of the way," says Joan. "It takes the fear out of going through this for John and for me."

"Gilchrist is more than just a medical resource," she adds. "They go beyond that—emotionally, it just makes everything so much easier. It's a really big comfort to know they're here."

Joan is amazed at how well her husband has fared. He has maintained his sense of humor and is able to do the things he loves, like spending time outside, gardening, even going to the casino. "Before, he couldn't walk without a walker," says Joan. "He couldn't do anything. We thought he didn't have any time left. Now look at him. I don't want to say it's a miracle, but in a way it is."

Making Every Moment Count

For Gilchrist patient Yorleny Garcia Granados, every moment spent with her children is precious. So when her hospice nurse, Ashya Adolemaiu-Bey, told her she had won a Gilchrist raffle for tickets to an Oriole's game, Yorleny was thrilled for the opportunity to surprise her two sons, Jahir, 5, and Anthony, 6, with a day at Camden Yards.

Ashya had submitted Yorleny's name in the raffle knowing that the family would enjoy a special day out together. Yorleny, in turn, asked Ashya if she and her children would join her at the game, and the two families shared a wonderful afternoon at the ball park.

"I want to help her make every moment count," says Ashya. "We had a great time at the game...We made a memory for her children that day."

Originally from El Salvador, Yorleny came to the U.S. at age 21 in search of more opportunity and a better life. But after having difficulty breathing one day at work, the soft-spoken, single mother of two was shocked when doctors at the hospital delivered devastating news: her heart was failing due to a congenital heart defect. A heart transplant was the only treatment, but her immigrant

status rendered her ineligible.

Yorleny knew she wanted to spend her remaining time at home, living each day to the fullest and taking care of her two young children as long as she could. So she chose hospice care.

The expert medical care of the Gilchrist hospice team keeps her pain and symptoms under control, allowing her to keep living life on her own terms. She remains an active member at church, where she volunteers as a greeter, and enjoys spending time with her brothers and cousins.

Yorleny is grateful for the care she has received from Ashya and all of her Gilchrist team, which includes a social worker, chaplain and child-life specialist. "They care for me and worry for me. I have a special love for each one, and I always pray for them," says Yorleny.

Despite the progression of her heart disease, Yorleny is not afraid of the future. She draws strength from her faith and her family, and the confidence that her Gilchrist team will be there to help. "Whenever I call, they answer quickly and solve what I need," she says. "They always take care of me."
